Project: Addition of Dormer Window to Match Neighbouring properties and ground floor kitchen extension to create more kitchen space

The proximity of the Lifeboat Museum, a key heritage asset locally listed for its significance, necessitates a nuanced approach to the proposed alterations. Drawing on the precedent established by application APP/17/01798/F, the alterations have been meticulously designed to ensure that the dormer window and single-story extension will not impinge upon the setting of the Lifeboat Museum. This careful planning affirms that the alterations will have a negligible impact on the visual and historical context of neighbouring heritage assets, preserving the integrity of the conservation area.

5. Design and Material Considerations

The design approach for the alterations at 4 Ballard Road has been guided by a commitment to historical accuracy and sensitivity to the property's heritage. By retaining the original Victorian brickwork and selecting materials that are sympathetic to the era, the alterations are designed to blend seamlessly with the existing structure and contribute positively to the streetscape. The introduction of a dormer window, chosen over alternatives like French doors, exemplifies a design decision that respects the architectural language of similar properties within the conservation area.

6. Parking and Landscaping

It is important to highlight that there will be no proposed changes to the existing parking arrangements or landscaping. This decision ensures that the alterations remain focused on enhancing the building's heritage value without altering the site's established spatial dynamics or visual appeal.
