Summary The proposal seeks advice on the construction of a roof terrace to a mid terrace, three storey residential dwellinghouse. Officers consider that this would result in harmful overlooking to the windows in the house immediately opposite. An application in this form would most likely be refused permission. Site The application site is a three-storey, mid-terrace residential property located on the southern side of Canning Cross. The site is located within the Camberwell Grove conservation area, though it is not listed. The nearest listed buildings are located to the east of the site along Camberwell Grove, a series of grade II listed buildings. Proposed development The proposal involves the construction of a roof terrace at rooftop level of No 3b, including a 1.2m glass balustrade running around the outside of the proposed terrace, with the balustrade setback approximately 0.2m from the edge of the roof.
