

This document explores and analyses the existing house's constraints and opportunities. It includes concepts and principles that we believe should be taken forward in the design.


3B Canning Cross is an elegant 21st century house.

I. Map of Camberwell Grove conservation areas


### 2.2 Location




Location Plan





## 2.6 Neighbouring Conditions

The neighbouring properties on Canning Cross are following the same pattern, with the level changing only slightly.

All properties have facades lined with London Stock brickwork. No 3A and 2 created roof terraces with glazing. The directly adjacent No 3A has extended their ground floor outside area with a brick extension and slate roof featuring 4 skylights.












Ground Floor Plan



4.0 Pre-application feedback

### 4.1 Feedback from Pre-App:

1. Loss of privacy: The proposal raises significant privacy concerns in respect of No 28 on the opposite side of Canning Cross.


Our response: we have updated the glass at the front of 3B Canning Cross to be frosted, and significantly set back.

2. Daylight/Sunlight: [care to be taken not to impact] sensitive windows on the opposite side of Canning Cross

Our response: we have set back the balustrade from the edge of the roof. This passes the 25° light test.

3 .The proposed balustrade would generally match that of the previously approved scheme at No 3a, and would therefore have a comparable impact on the conservation area. The scheme is generally acceptable in design and heritage terms Our response: we have therefore kept the aesthetic the same, although frosted and set well back from the edge.






