This is repeat and identical application for trimming works on the Magnolia, both of which were granted in 2019 and 2021. We are wishing to prune back the Magnolia (TPO: Magnolia 20521 TPO order: HDC1091-2001) which is situated in our property's front garden, as it has become very large. We wish to decrease the height of the tree to approximately 1 meter below the telephone wire which is running through it. We also wish to decrease the circumference of the branches by approximately 2 meters to bring the tree back within our properties marked boundary and promote healthy future growth of the tree. We also wish to remove any dead wood from the tree to promote healthy growth.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
