Lime (T1, T2, T3) - It is recommended to regularly pollard the branches of trees to their previous pruning points when they become too long and heavy, as this can cause them to snap and pose a risk of failure.

This species of tree is highly suitable for this operation, as it will trigger dormant buds and reduce the risk of failure. Trees with crowns that pose a risk to children playing or setting areas are not tolerated by homeowners and should be managed cyclically every five years.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
