| There is a single large tree in the garden that has been allowed to grow over the years without any reduction. I bought the house in December 2023 and when viewing the house in the summer months the height and width of the tree means that the house is in shadow. I want to reduce the tree by 1/3 and will use an arborist to undertake the work to ensure that the health of the tree is maintained.  The outline of the garden and house is shown in red in the document plan.pdf. The tree location is identified by a yellow star.  The picture Tree reduction ing shows the tree itself |

The tree is a silver birch
