T1: Sycamore. Removal to ground level. Tree is covered in Ivy, there are multiple dead limbs evident and the top has failed and is stuck in the middle of the crown.

T2: Beech. Removal to ground level. Tree is far too close to the property and is at risk of damaging the structure.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
