I am unable to provide a photo - I've used the smallest file size I can (39KB) but it is not sending through - please can you advise how best to provide the photos?

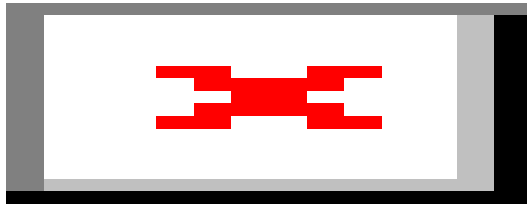

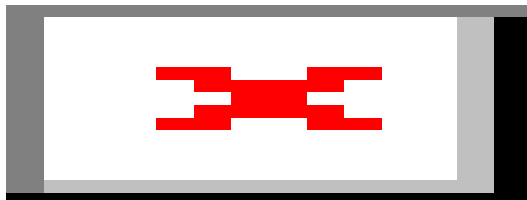
