T1: Common Beech Tree - there have been some larger branch failures over the last few years within close proximity to buildings and cars below. We would like to request up to a 4 meter reduction in height and spread to alleviate some of the wind sail, manage the trees size and reduce the possibility of future damage. Longer laterals in the lower canopy to reduce to secondary growth points to maximise spread reduction without over cutting.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
