Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The Ash tree on this property, on which the works are proposed, is on a raised bank and has bracket fungus on the roots, a neighbouring Ash tree which was taken down a few years ago was internally rotten with black fungus. This Ash is a large tree which is over a shed and appears vunerable in high winds. I therefore wish to remove the tree. There are other, better tree specimins in the area, including a small liquidamber in the gounds of this property. I would be happy to plant another tree in the grounds.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
