T1 – lateral reduction of a Scots Pine tree to provide a 1.5-2m clearance from walls and roofs, retaining height and form. Remove the two lowest branches. Crown lift by up to 3.5m to suitable growth points.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
