Description of Proposed Works

Please describe the proposed works

Construction of a small porch to the front of the main entrance of 238 Springvale Road, floor area 3.5 m2 internal, 4.8 m2 external. The proposed structure is non-habitable but it will be constructed to standards similar to the rest of the dwelling, i.e., external brick/internal block cavity walls with insulation, double glazing and clay tile roof to all relevant building regulations. As the brickwork and roof are particular features of the existing dwelling, care will be taken to make the porch appearance harmonious with the current building through, for example, use of closely matching bricks (Oakthorpe Red Multi which is the closest match to the existing Butterley bricks which are no longer in production) and tiles (Dreadnought Country Brown as per the existing roof).

The proposed development will not adversely impact surface water drainage at the as the new porch will be built on an area which is currently asphalt. There will be a very small reduction in space for vehicle parking and turning at the front of the property but this will make no material difference to these arrangements.

Butterley Capel Multi-stock Brick Facings (Red)

Proposed materials and finishes:

Side walls to abut existing brick elevations to be of brick construction using bricks to match existing bricks as closely as practicable (Butterley Capel Multi-stock Bricks are no longer produced). Front of porch to be white-framed double glazing. In addition to the new porch a replacement dwelling front door of equivalent size, colour and position to the extant front door will be installed.

Existing materials and finishes:

The main house roof and the pitched roof that abuts the front elevation above the front entrance door are constructed using Dreadnought Rustic Brown clay tiles set at a 35 degree pitch.

Proposed materials and finishes:

A gable that intersects the existing roof abutment will be constructed using the same Dreadnought Rustic Brown clay tiles as the main roof, also at a 35 degree pitch.
