NOTES TO BUILDING OWNER

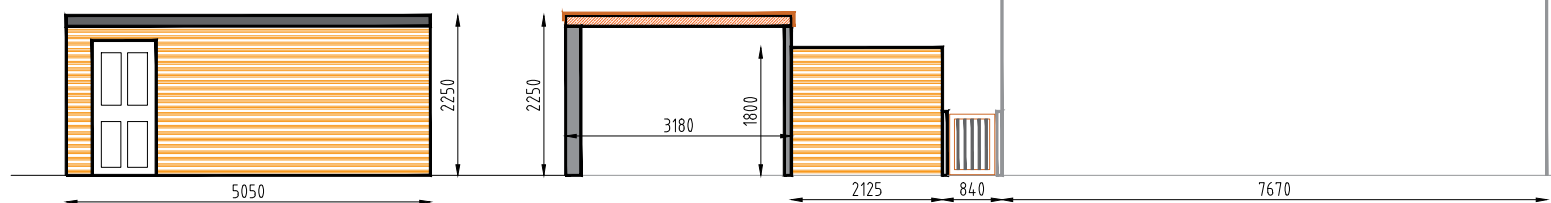

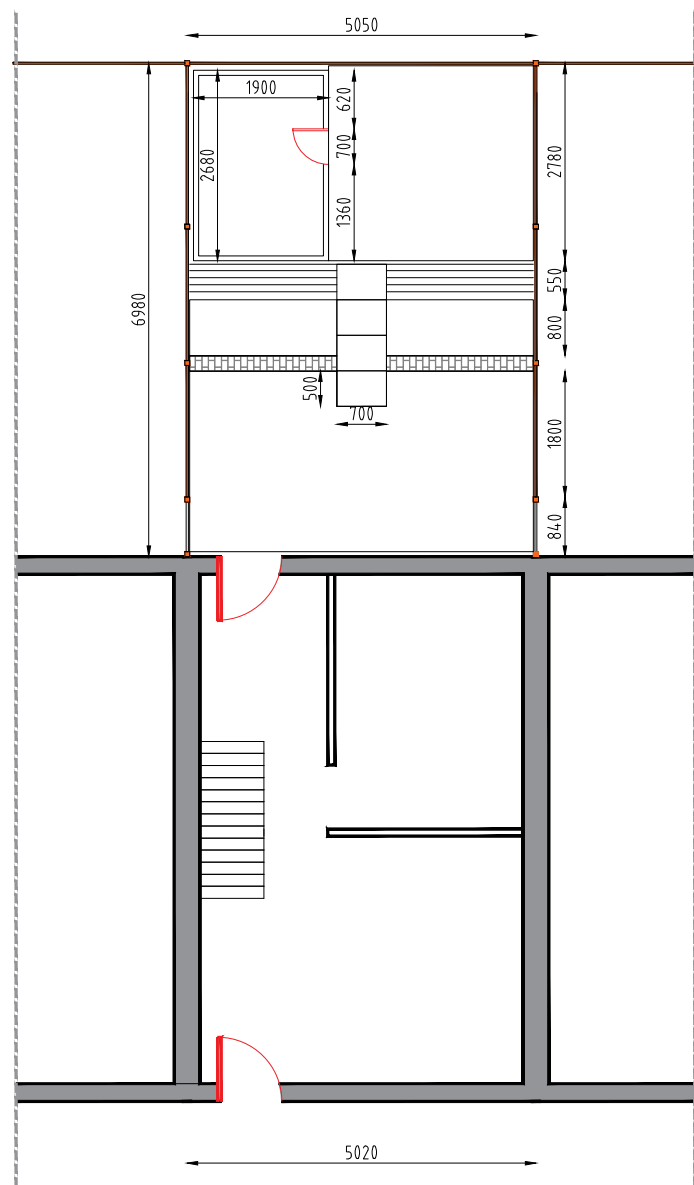

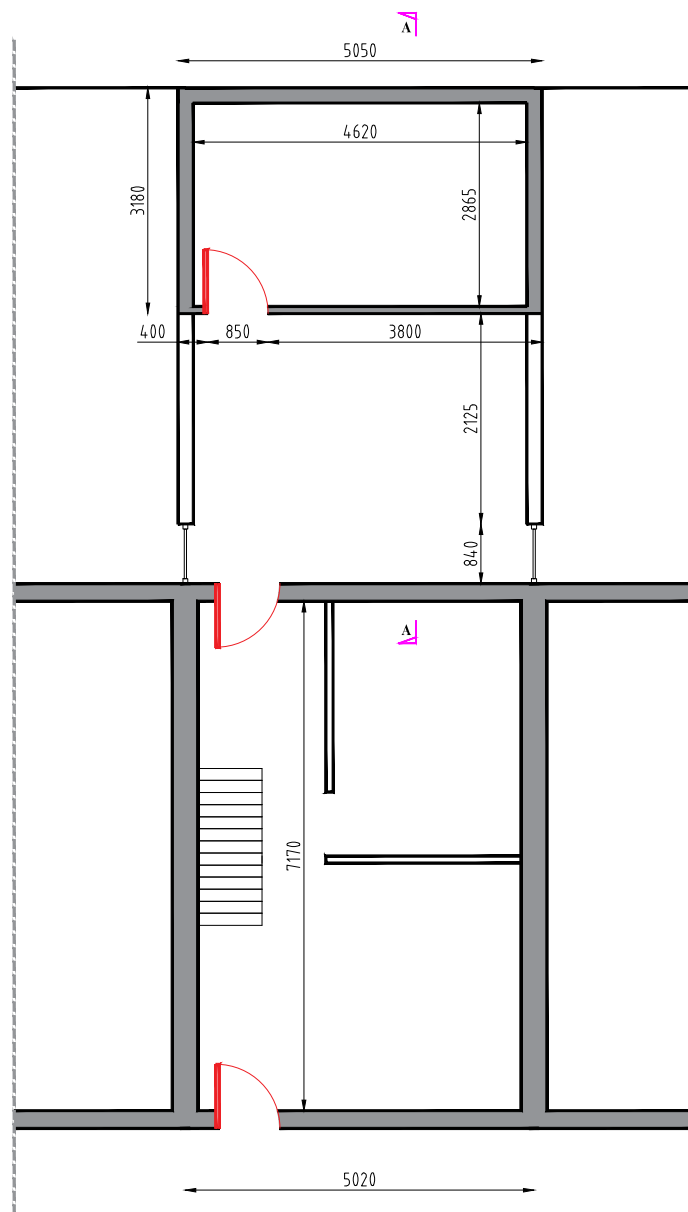
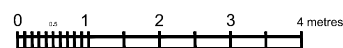


FRONT ELEVATION

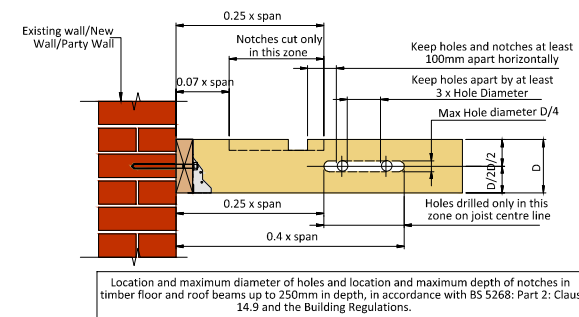
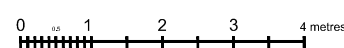

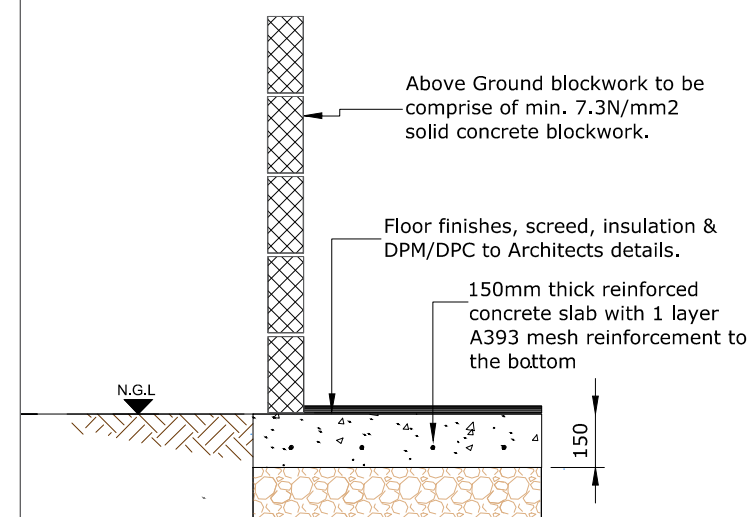
PRE-EXISTING GROUND FLOOR PLAN (SCALE 1:100)



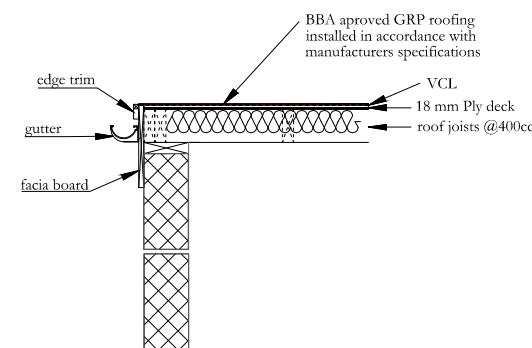
EXISTING GROUND FLOOR PLAN (SCALE 1:100)
