Description of Proposed Works

Please describe the proposed works

Our Level 3 building survey advised that immediate replacement for the current flat roof and conservatory roof of the property is needed. The current flat roof and conservatory roof is not fit for purpose and is leaking. The conservatory is also letting in plants and is not energy efficient.

Following a three construction consultations, we have been informed that a flat roof is necessary. All companies have confirmed that there is not enough room for a pitched roof to be installed.

There is currently a significant leak in the extension due to the different heights of the flat roof and the conservatory roof.

A flat roof extension with a sky light and sliding doors will increase the energy efficiency of the property by allowing for more natural ventilation and reducing the need for artificial heating and cooling. The skylight will also increase the amount of light coming into the property which will reduce electricity usage.

The sliding doors will be black which will mirror the black frames at the front of the property. The sliding doors will be double glazed to ensure greater property energy efficiency.

Our neighbours at 34 Cardiff Road have been consulted about these plans and recall the previous homeowner having a number of issues with the current flat roof and conservatory roof with persistent leaking. Our neighbours at 34 Cardiff Road understand our reasons for the proposed development and did not make any objections to this.
