We would like to carry out a crown reduction for both sycamore and ash trees in location G8 on the TPO plan (attached to application) as there are some very low hanging branches over the shared driveway that can cause impediment to larger vehicles.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
