T1 Beech tree - To draw back the branches of the beech tree from the house by 3-4m, crown lift lower branches by approximately 2 m, draw in branches on north side by 2m under the old pruning points and cut back overhanging branches. To keep tree under control as it is starting to dominate the front of the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
