T1 Lime tree for removal

Reason - The tree I require felling is a Tilia (Lime) and is only 5meters from my property and 6meters from my neighbours. It is extremely tall, leaning slightly, and the top few metres are rotten. 6 trees have already come down during the westerly winter gales, and a further tree is badly leaning in the bottom field. The problem is 3 fold. Firstly, Clifford and the surrounding area sits on a band of clay with a layer of top soil above the clay. Tree roots cannot penetrate the clay, so grow sideways, compromising their stability. Secondly there are many springs in the area, so water flow is on top of the clay layer. The land slopes west to east, so the trees are rooted almost continuously in soft shallow wet soil. Thirdly, the 3 fields in which the trees have come down are totally exposed to the strong westerly winter gales. There are no buildings blocking the force of the gales. All the above can be easily supported.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
