Group of 6 Limes - crown lift to 5.5m, due to good arboricultural practice to manage size of trees in their location. Remove all basal growth and deadwood. Sever Ivy on all trees. Remove all vegetation between the group of trees. Fell to ground level end right tree as this tree has lost its crown.
