- T1 oak tree, lowest extending western limb pruned back to stem, 180mm cut approximately.
- T2- ash tree fell
- T3 Hornbeam, 2m crown reduction.
- T4 Oak, 2m crown reduction
- T5 Beech, north side branch reduced back to for (120mm cut), remaining branches overhanging approximately 2m tip reduction to maintain shape of the crown.
