1. SCOPE

- 1.1 Hillside Trees Ltd has been engaged by Ross Hayward to assess a mature Western Red Cedar tree currently growing within the garden of 95 Coombe Lane, Bristol, BS9 2AR
- 1.2 The purpose is to assess the condition of the tree and make appropriate recommendations for management.


3.0 LEGAL

- 3.1 T1 (Western Red Cedar) is subject to Bristol City Council Tree Preservation Order No. 1105 2009. Consent for works should be obtained from the Local Planning Authority.
- 3.2 It is an offence under the Wildlife and Countryside Act and Countryside and Rights of Way Act to disturb a nesting bird. Work to trees/shrubs with the potential for nesting birds, which also (with few exceptions) enjoy statutory protection, should be carried out between the end of August and the end of February. Further advice may be obtained from Natural England.


