Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposed hip-to-gable and rear dormer window will not add more than 50 cubic metres to the roof slope. Therefore, keeping within the 50 cubic metre allowance. The dormer will be set back from the eaves by 0.2 metres and will not extend beyond the plane of the existing roof slope that forms the principal elevation. The proposed roof lights to the front slope will not protrude more than 150mm from the roof slope. With these criteria, the development complies with Class B and C of Part 1 of Schedule 2 of the GPDO therefore be deemed lawful. The proposed front porch would meet the floor space(3m2) and max height(3m) requirements set out under Class D of Part 1 Schedule 2 of the GPDO permitted development and, therefore would be deemed lawful.
