Sycamore. T1 Remove; fell and grind stump to a suitable depth to allow for a new tree to be planted in or as close to its present location. Plant one new suitable species 'Standard' sized tree in its place and maintain to get established.

Reasons for removal of the tree.

TPO on Sycamore tree should have been revoked in 1999 when the houses were built. 25 years later and at more than 20 metres high and with a spread of 14 plus metres it is now growing against the boundary wall of the property and the branches are reaching over the patio, which was built 7 years ago.

The applicant is extremely worried the roots are now doing damage underneath their house. Their neighbours, including The Fleece pub, are also concerned for their properties and liability insurance if damage is caused by the tree.

Cracks have appeared in the applicant's wall holding up the patio and flags, laid 18 months ago, and are now lifting up again. A new summerhouse 10 years ago has had to be moved twice and now demolished because of movement of the floor. The summerhouse was replaced by 2 small sheds 3 years ago and 18 months ago the side panels have had to be replaced and more flags laid for stability. The resident at number 5 Kilners Croft has a disability and has to have a level surface to walk on hence some of the garden and patio having flags. Because of the slime, dirt and debris shed by the tree it is becoming a trip and slip area and a safety hazard for everyone in the tree's vicinity.

The applicant and their fellow neighbours are willing to provide another suitable tree to be planted in its place.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
