A Oak tree in the neighbouring property (NO.27 The Avenue) is causing excessive shading and leaf fall in the garden of 25A The Avenue, I suggest a cut back away from the boundary of 25A to reduce this.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
