- TD4 False Acacia, Pollard at 4m. Poor crown but not yet dead. Potential to fall on drive to hospital.
- TD6 Sycamore, Fell. Sooty bark disease.
- TD7 Sycamore, Sever Ivy and reinspect. Close to fence to drive.
