T1-20 Leylandii hedge Boundary hedge between No10 and No 8

Reduce height by 1/3rd (3.5-4.5m)
trim both sides by 1.5-2.5m

Hedge has not been maintained for 10+ years and the home owner wants to reduce the height as parts of the hedge have recently snapped due to end weight.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
