Materials

1. Red multi brick facing brickwork - Ibstock Parham Light multi facing brickwork.

2. Flat metal panel cladding system of varying widths in the following colours; RAL 7047, RAL 5014, RAL 2001, RAL 1004, RAL 1016.

3. Flat metal panel cladding system, RAL 7042.

4. Render system - Weber Monocouche Render, colour chalk.

5. Thermawood timber louvre system in PPC steel frame with concealed fixings. Steel frame to be RAL 7047.

6. Aluminium Louvres, RAL 7042 matt.

7. Stack-bonded 40mm x 590mm brickwork panels, Gima Roman bricks, colour Glazing to stair cores and feature elements to be double glazed curtain walling system with no external pressure plates & caps or retaining clips.
 Glazing to be fritted/etched in regular bands where shown on elevation.
 Glazing to retail units to be PPC Aluminium framed glazing system to future occupiers requirements, colour RAL 7012.
 Glazing to retail units to be double glazed curtain walling system with no external pressure plates & caps or retaining clips, by Tenant.
 PPC aluminium channel detail, colour RAL 7012.
 PPC aluminium projecting window surround, colour RAL 7012.
 PPC aluminium feature louvres, colour RAL 7042.


