Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

1 no Fraxinus excelisor (Ash), 1 no Laurus nobilis (Bay), 1 no Tillia cordata (Lime), 3no Acer pseudoplatanus (Sycamore). Trees have been marked with a white marker

Following further assessment prior to excavation works for Listed wall repairs the root structure of the trees above will be affected by the works leaving the trees in a dangerous condition and chance of failure towards the wall significantly increases.

We would propose the removal of the trees and once ground works and wall repairs are complete trees will be replanted at least 4m away from the wall in a staggered line. Replacement trees to be 2no Fagus sylvatica, 1 no Tillia cordata, 1 no Quercus robur, 1 no Lauris nobilis and 5no llex Aquiflolium to give lower evergreen cover during establishment. Trees to be 1.5-2m whips.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
