Ornamental Pear (G1) Reduce the height of the row of trees/hedge by approx 1.5m back to the previous pruning points. Reduce lateral spread on both sides by approx 0.3-0.5m.
Beech (G2) Reduce the height of the row of trees by approx 1.5m back to the previous pruning points. Crown lift by 1m to clear garage roof.
