- (T1) Copper Beech Tree, Crown reduce low branches by 2 metres to clear from the house, Crown lift the canopy by 3 metres over the garden and footpath to give clearance and light to the propertys garden.
- (T2) Beech Tree, Fell tree due to its position in the garden and increasing damage to the back fence.
- (T3) Plum Tree, Fell tree due to its position in the garden, recently damaged by wind and heavely leaning over the boundry towards the neighbouring property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
