- 1. Lime Clear the lower sections of the tree to allow for future inspections. To lift the crown to provide suitable clearance for road and property.
- 2. Lime Going on the felling option. Remove as the tree is heavily suppressed, demonstrates poor form and provides limited long term potential. Its removal

would benefit the adjacent trees.

3. Lime - Clear the lower sections of the tree to allow for future inspections. To lift the crown and prune back from the house to providing suitable clearance

from the property.

- 4. Lime No work
- 5. Beech To lift the crown and prune back from the house to providing suitable clearance from the property.
- 6. Hornbeam To provide suitable clearance from the property.

- if there are many trees on the site, make clear which tree(s) are included in this application by:

 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
