Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 Acer pseudoplatanus - remove overhanging limb to clear boundary, approximately 3m height

T2 Ulmus procera - standing dead elm. Right on the border, potential to snap or fail causing damage or to plot, risk to humans. - remove to ground level

T3 Acer pseudoplatanus - self seeded large sapling 10cm dbh - remove to ground level

T4 Acer pseudoplatanus - semi mature lower limbs encroaching onto plot - reduce limbs back to boundary

T5 Fraxinus excelsior - mature, lower limb approx 6m high encroaching onto plot - reduce back by 1-2 meters to suitable growth point.

T6 Quercus robor- mature, covered in ivy, lower epicormic growth encroaching onto plot- remove/reduce back to boundary, ring bark ivy to prevent further growth reducing weight and wind sail effect over time. Leave severed ivy as habitat

Client wants to clear boundary line to install a boundary fence. Just asking to clear dead trees and remove overhang. Waste to be removed and recycled leaving small habitat piles to encourage wildlife.

Customer is willing to replant once the plot has been completed. Considering Sorbus acuparia or Betula pendula possibly acer griseum. 1-2 trees once the development is completed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
