The tree has grown approximately xxxx cm in the last 50 years since the house was built.

The gap has narrowed between it and the garage wall to 59 cm, this is causing sever access arrangements to entering the premises.

It would also make access for emergency services I.E Medical and Fire extremely difficult.

Replacement trees could be made to the rear of the property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
