A large oak tree - at least one branch requires cutting back away from the neighbour's property. Proximity at the moment is approx.2 metres from touching the house.

There is also another branch which has a longitudinal split it and is being supported by another branch. Potentially could fall into a neighbouring horse field.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
