Conclusion of the pre-application response as follows - Officers would unlikely be able to support the proposal due to concerns raised in terms of the character and appearance and residential amenity. The scale of the proposed development should be reduced and should have particular respect to Policy HD7 of the Radlett Plan 2021 in terms of design.

The overall proposal has now been amended to take account of the pre-application comments including the following elements:

- Removal of bays
- Removal of cladding
- Reduced rear extension depth
- Rights of light for neighbouring properties shown on elevations, to show no adverse impact
- Reduced ridge height to match existing
- Removed plant room outbuilding to side
- Removed fencing
- Reduced the front canopy size
- Set back the entrance to front elevation

Elements of the size and design which remain from the pre-application design are as follows. The justification is that these features are present at several other properties, found in the immediate locality of the site - See Street scene comparison plan for annotated details accordingly. Therefore, the proposed scheme is considered to be in keeping with this actual character of the street scene and not contrary to it.

- Larger crown roof areas are found on several nearby properties
- Single storey extensions of full width / substantial widths of plots.
- Large rear extensions due to garden already small.
- Front corner infill
- Small courtyard infill
- Rear extension infill
- Extending in line with the boundary on the angle.
- Front canopy.

These elements are therefore considered to be acceptable due to the numerous other examples of these features found in the locality.
