Details of the pre-application advice received

The formation, laying out and construction of a new access to Squires Road required in connection with the provision of a hard surface for any purpose or the replacement in whole or in part of such a surface would be permitted development. I have consulted NCC Highway Authority who consider the speed of vehicles travelling along Squires Road is likely to be 30mph and recommend the application of the Manual for Streets visibility standard (2.4m by 43m – see diagram below) although this will require extensive hedgerow removal. Furthermore it is advised that the access be no less than 15m from the junction with Marsh Road which it appears to be according to the annotated satellite image you provided. It is recommended that you obtain a highway boundary plan: <https://www.norfolk.gov.uk/roads-and-transport/roads/highway-boundaries-new-private-and-adopted-roads/highway-boundaries>. Furthermore it would be helpful if you obtain a topographical survey (or a suitably scaled plan) and draw achievable visibility onto it, showing vegetation that may need removal and the highway boundary 2.4m x Y distance in both directions (probably 43m):

It would be beneficial to the character of Marsh Road if the existing access is closed by planting a new section of hawthorn hedge across.
