Hello,

I bought the above property in September 2023, just before the awful wet and windy weather. At some point over the winter, one of the trees in the garden has fallen down. On inspection, it looks like the tree itself may have been dead for some time, and essentially having been propped up by the ivy growing round it and a large rose bush intertwined. I am attaching a few photos for your information. The tree has a silver medallion with the number "0138" - Having only recently moved into the Conservation area, I am assuming that all trees in my garden with such a medallion are protected trees- is this the case? However, when I use the search facility on the Council website, no TPO's come up for my house, other than it being in the conservation area boundary.

I wonder if you could answer a couple of questions please:

- 1. Given it has a number, are you able to identify what this tree was?
- 2. Our intention is, for the short term, to leave the fallen tree in-situ cut into pieces to provide a habitat for wildlife. However, we would like to replace the fallen tree; would the Council have any preference as to what it would like to have planted?
- 3. Now the weather has improved, I've started to get into the garden, and there are at least 3-4 other trees in the (quite substantial!) garden that I have identified with similar medallions; is there a record somewhere I could access detailing what all these trees are, given that nothing comes on on the interactive planning map?
