Permission was granted for removal of epicormic growth up to 4m TPO 7231 in 2023 but there was an admin error on your part and the first part of the request was overlooked (as agreed by Tim Holman). Originally it was requested to have minor branch reduction on SW side to address rebalance of the tree due to removal of trees on adjoining land used for property development by neighbour.

A site visit by the arborist this year revealed the overlooked permission (frustratingly). The arborist is now suggesting getting permission for "up to 2m reduction of the overall crown with balanced reduction for reasons of light and enjoyment of our garden"

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
