# Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

G1- a group of 6 ash trees, fell to ground level. 5 day notice.

Nick Conway has been out to site and agrees the trees need removing because all the trees have heave and children play under the trees and it is a safety issue as 2 oak trees have fallen from the council land into the area and it has made the trees more open to the wind when it blows through and some of the roots are showing decay in. It is a major safety hazard.

T1- oak tree- fell to ground level.

Again it is a safety hazard as the lean on the tree is going over gardens where children play and it is all weighted on the side of the lean and also has heave so it could fail at anytime and if there's kids under it then it would kill them. T2- ash-

This as has heave as well and people walk under it daily, it has heave again and lifting slabs to make it a trip hazard. It has been badly pruned in the past and it has signs of ash die back.

The customer is happy to re-plant with trees suggested by the council, which I think hornbeams would be nice or flowering cherrys etc.

- mark and name surrounding roads
- sketch in buildings, including adjoining properties
- add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
