Oaks x4 - Crown reduce trees along allotments boundary to Glebelands Silchester Road. Carry out a tip reduction of approximately 3m in height and 2m in lateral spread on the northern side only, pruning back to suitable growth points to maintain more of a natural shape and balance. Due to historic work on the southern side of the trees, no works will be carried out here.

Boundary mixed hedging - Reduce approximately 35m in length of boundary hedging to an approximate finished height of 2.4m to allow clearer light filtration into allotments.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
