The proposal seeks to establish a modest, but site appropriate, entrance to the grounds surrounding the house. At present there are timber gate posts and a post and rail fence (Circa 2001) set at the entrance to the garden grounds. (see image 1 & 2) This proposal is to replace these timber gate posts with brick gate piers set in line with the existing garden boundary. The brick gate piers will be $500 \times 2150 \times 500$ and will be constructed from bricks reclaimed from the demolition of the old billiard room. As part of this change the existing C20th post and rail fence will be replaced with a stone and earth bank to re-create what was there originally and narrowing the opening in the boundary.
