History:

2 x Lime trees have previously fallen over in March 2020 [B1] & March 2021 [B2] in high winds due to carrying a fungus disease " Kretzschmaria deusta" confirmed by Barnet Council on a site visit (6th March 2020). The latter tree [B2] caused extensive damage to neighbouring property's fences, garden walls and trees.

There is also evidence that at least 2x Lime trees have previously fallen [C1, C2]. This fungus is affecting the heartwood at the base of the trees making them very unstable and weak (see pictures attached of the existing fungus and heart rot of fallen trees).

An application for removal of [A1, A2, A3 and A4] in April 2021 when several of the trees showed the same fungus at the base of the tree and showing significant movement a the base of the tree. A third party arboriculturist (Joshua Wiggins from the Joshua Tree Ltd, Herts) confirmed the disease and recommended removal of the trees due to risk of them falling causing damage to neighbouring houses (application TCP/0123/22). These trees have been subsequently removed as well as the roots and stumps.

At the time Joshua Wiggins also pointed out that the lime trees [D1 and D2] were suffering from the same fungus but were not swaying as much with minimal root movement and it would be best to leave the trees. However in the recent weeks of April 2024 the trees, particularly [D2] have moved significantly with it leaning 10-20° off the vertical. There has also been definite movement of [D1] as it is now leaning over a fence panel that could have been previously been removed.

Tree [D2] is adjacent to a neighbouring brick-built garage (19 The Croft), approximately 4-5m from Leecroft homes on Leecroft Road, EN5 and 10-12m from my property. Tree [D1] is now over hanging my neighbours driveway (19 The Croft) where they park their cars and approximately 3m from my property. If either of the trees were to fall it would cause serious damage to property and pose a risk to life.

I request that in this application that 2x Lime trees [D1] and [D2] are given permission to be removed ASAP. A site plan and photographs of the trees have been added to the application.
