

STATUTORY DECLARATION

I, ANDREW GRIFFITH, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. That my full name is Andrew John Griffith and I live in the converted outbuilding to the east side of my parents [Doug and Joyce Griffith] house with my now wife, Emma-Gael Griffith [whom I married on 22 June 2019] and our son, who was born on 15 March 2021.
2. That I have read my father's Statutory Declaration sworn on 15th March 2024 which concerns its original construction, its original use and its conversion to a dwelling along with my use of the outbuilding in the location cross hatched on the plan attached at AG1.

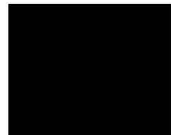

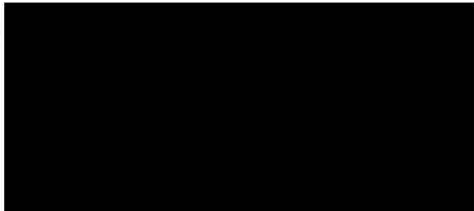

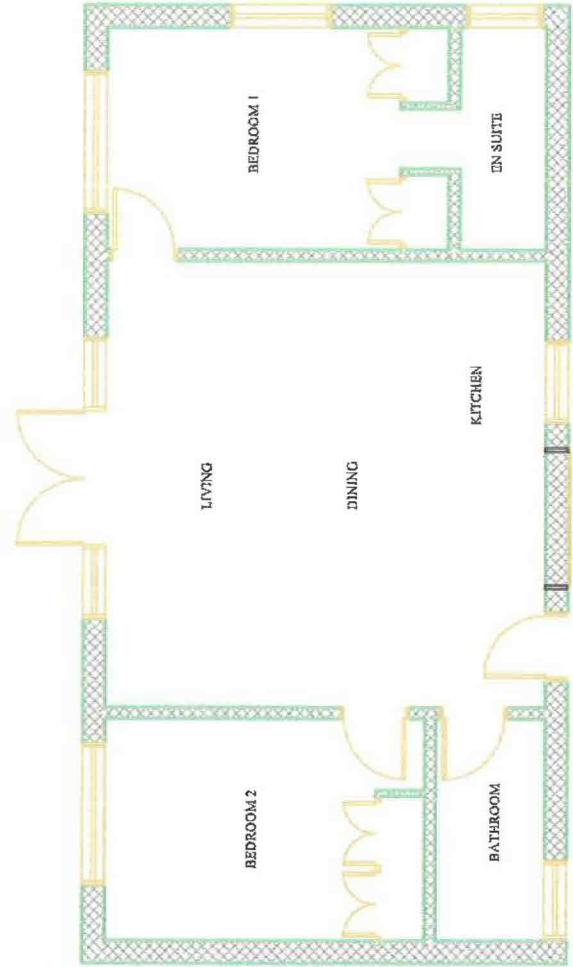
