

STATUTORY DECLARATION

I, EMMA-GAEL GRIFFITH, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. That my full name is Emma-Gael Griffith and I live in the converted outbuilding to the east side of my parents-in-laws [Doug and Joyce Griffith] house with my husband Andrew Griffith, who I married on 22 June 2019.
2. That I have read my father-in-laws Statutory Declaration sworn on 15th March 2024 which concerns our use of the outbuilding in the location cross hatched on the plan attached at EGG1. I can confirm the statements made in his Declaration are accurate and true.
3. The floor plan of the house that we live in is attached at EGG2 of my Declaration. This is an accurate representation of the room arrangement of the house that I have lived in with my husband, Andrew, since we moved in on 1st April 2017 to the present day.

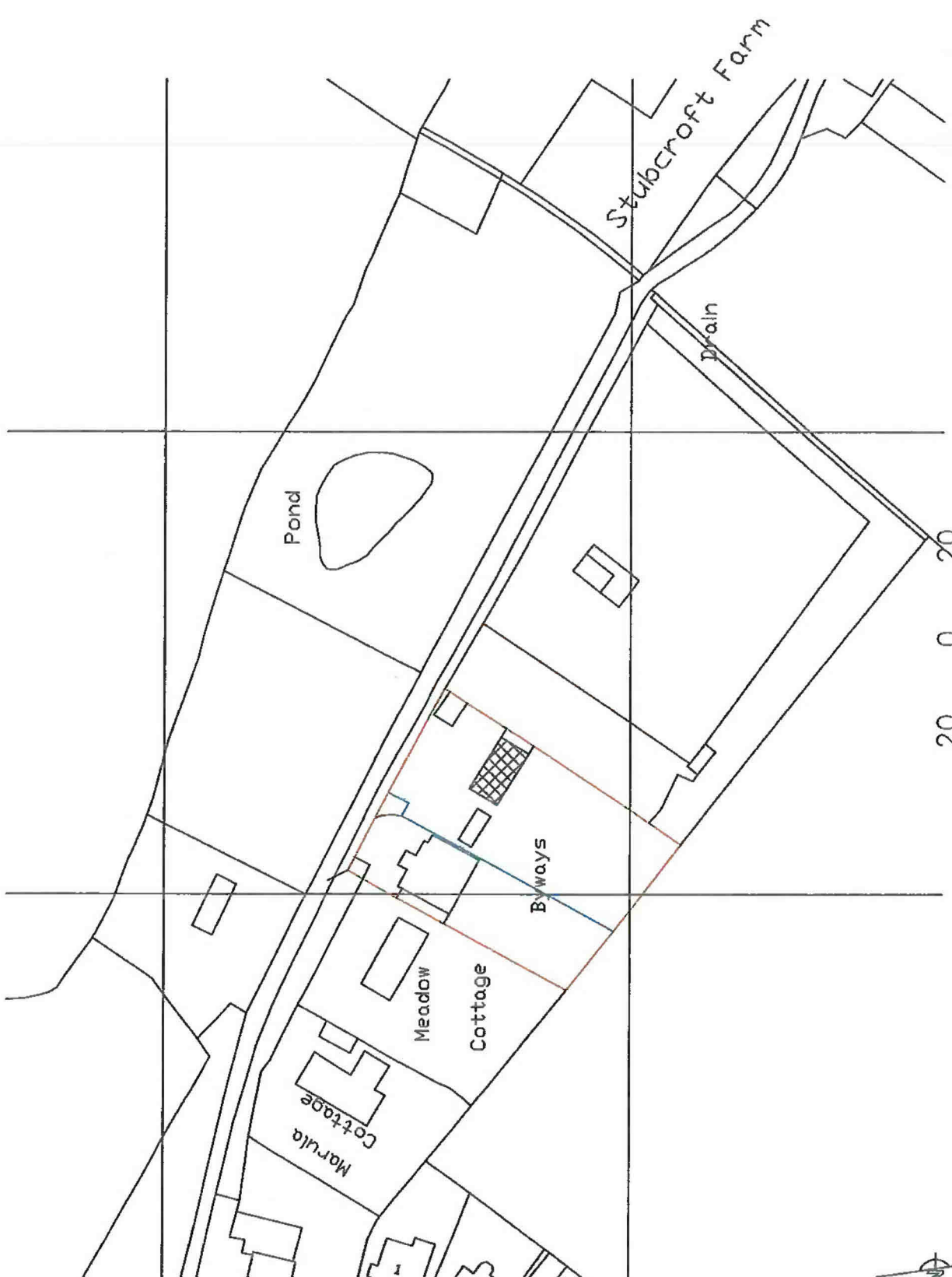

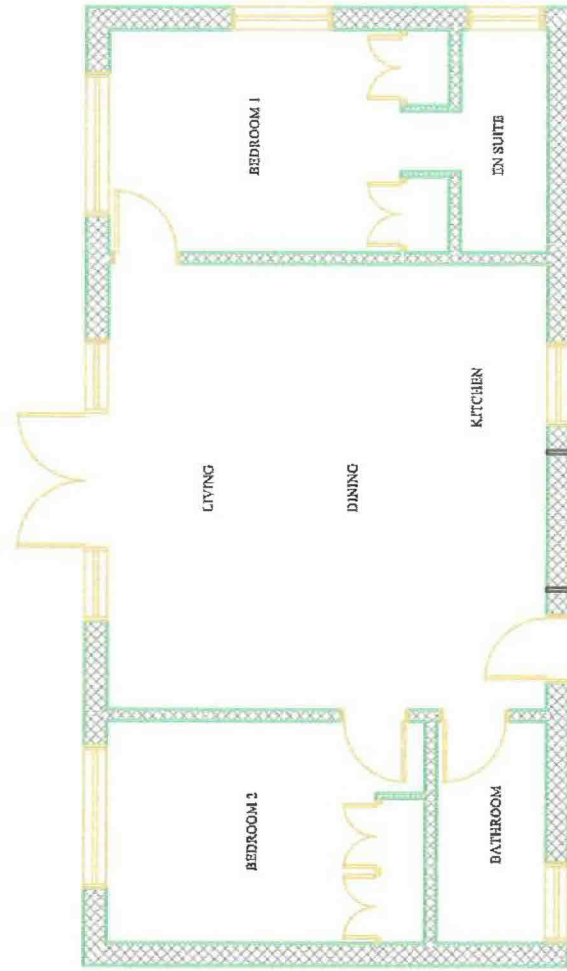
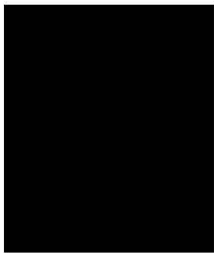
