

## STATUTORY DECLARATION

I, DOUG GRIFFITH, DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. That my full name is Douglas John Griffith and I live at Byways, Church Farm Lane, East Wittering with my wife Joyce. The extent of our ownership is edged with a red line on the plan attached at DG1.
2. In 2013 we obtained a Certificate of Lawfulness of Proposed Use or Development to "*Construct a new ancillary residential building to be used as a double garage and hobby room*" under council reference EWB/13/00719/ELD.
3. We commenced works on the building in March 2014 and completed it in early 2015. Whilst there were a few minor changes to the fenestration and internal layout of the building I did not consider that those mattered as it was not a planning permission that we obtained and the use remained incidental to the main house. The floor plan of the building as completed is attached at DG2. Its location is cross hatched on the plan at DG1. As completed the building had a main machinery store area with a gym to one side and a store for canoes and surf boards the other side. It had a concrete floor throughout, but had insulated external walls. Receipts for the base works; OSB for the structural timber walling; windows; and the garage door which I recall was the final item in February 2015 are attached at DG3.
4. At that time our son, Andrew, lived with us in our property and he was 27 years old when the building was completed. A lot of the items stored in the building were his and he would be in the building most days. I think from this he felt it would be much better if he had his own independence and he asked us if it could be converted so he could live in it and be independent. We agreed to this and commenced works on converting the building in November 2015.
5. We undertook the works slowly due to time and cost restraints. First, I insulated the loft; installed the heating pipes; and plasterboarded the walls and fitted a bathroom. This was in October / November 2015 and I attach receipts for those works at DG4. At this time the building continued to be used with a gym and for storage – ie for purposes incidental to our house.
6. Works then stopped at the end of 2015, due to finances, and did not recommence until the summer of 2016 with the fitting of a gas boiler in June 2016; lighting in September 2016; kitchen units, white goods and shower door in late December 2016 and I attach receipts for those works/items at DG5. The works were completed in March and our son and his [then] girlfriend, Emma, moved into it on 1<sup>st</sup> April 2017.
7. At that time, we erected a fence between the two properties in order that we could all have our own private space and privacy. The alignment of the boundary fence is indicated with a blue line on the plan at DG1.

8. They are now married and our grandson was born on 15 March 2021.
9. I attach at DB6 a floor plan of the building as converted and confirm that this has been its layout since the end of March 2017 to the present day.
10. I can confirm that since 1<sup>st</sup> April 2017 the converted outbuilding dwelling has been continually occupied by our son and now daughter-in-law. They have all the facilities they require to live wholly independently from my wife and I. They are not dependant on us for anything nor us on them.
