

Various locations at Scott Business Park, Plymouth;
As per DTS Consultancy Quantified Tree Risk Assessment work recommendations (attached)
G005 - Dismantle, Fell & remove single Ash tree in group.
Grind out stump to approximately x200mm below ground level & backfill grinding pits with arisings.
Lime & Chestnut Trees - Re-pollard (except for the hornbeam) to previous cut height circa x6 metres from ground level.
To supply & plant;
1x Ginkgo biloba - Selected Standard 10-12 cm girth x 3.0 metres in height.
G010 - x2 Mature Ash Trees - Sectional dismantle and fell to ground level.
To supply & plant;
2x Common Lime Trees (Tilia x europaea) - Selected Standard 10-12 cm girth x 3.0 metres in height.
G011 - x2 Mature Alders - Crown reduce by 2-3 metres allowing for up to 2 metres clearance from building
G017 - x4 Mature Black Hybrid Poplar - Pollard all 4 trees at x4 metres in height.
To supply & plant;
1x Walnut Tree - Selected Standard 10-12 cm girth x 3.0 metres in height.
G020 - Row of Mature Alders - Re-pollard all trees to previous pollard points.
T001 - x1 Mature Poplar - Re-pollard at previous cut points approximately 8 metres from ground level.
To supply & plant;
1x Tulip Tree - Selected Standard 10-12 cm girth x 3.0 metres in height.
All works carried out to BS 85452014. Trees from nursery to independence in the landscape Recommendations.
Devon Tree Services Ltd will endeavour to obtain good quality plants that comply to BS3936.
T002 - x1 Suppressed Weeping Ash Tree - Dismantle, fell & remove to ground level.
T007 - x1 Mature Alder - Reduce NW aspect away from building by leaving a 2 metres gap.
T008 - x1 Mature Alder - Reduce NW aspect away from building by leaving a 2 metres gap.
T009 - x1 Dead Ivy Covered Alder - Sectional dismantle and fell to ground level.
T013 - x1 Over Mature Black Poplar Hybrid - Monolith tree at 4 metres from ground level.
T018 - x1 Mature Common Ash Tree - Sectional dismantle and fell.
Remove all cut material from site & return to a Devon Tree Services depot for recycling, leaving the area safe, clean & tidy.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

• indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:

- mark and name surrounding roads
- sketch in buildings, including adjoining properties
- $\circ~$  add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
