The proposal could therefore be acceptable in broad principle but subject to the following considerations below.

Overall, officer's would be unable to support the scheme as it currently stands. Insufficient information has been submitted with the enquiry such as existing and proposed street elevations showing the relationship between the proposal site and adjoining units. Officers raise strong concerns as to the proposed two-storey front extension and impact on the established building line, overdevelopment of site, massing with regards to the industrial units when viewed together and impact on the proposed provision of parking. No information has been submitted with regards to impact on parking, whether the proposal would intensify the use of the site by virtue of increased staffing numbers and customers, furthermore the impact to highways as a result of no parking provision on site. Impact on flood risk would be subject to SuDS information at application stage or a pre-commencement condition at application stage in the event an application was submitted. Noise and light pollution impact would be subject to the further details of the scheme and consultation with the Environmental Health Team. Impact to trees would be subject to the submission of full arboricultural information at validation or consultation with the tree officer in the event a formal application was made.
