 The specimen has lost a significant major limb at some 10m, thus leaving the remaining canopy vulnerable to further failure, due to its position over the rear garden of 'Parbrook' this gives safety a concern. Also it has an extended lower limb, reaching out over Parbrook, various 'shed' limbs, with evidence of upon the root plate. General poor condition and vulnerable to further failure's.

Re plant (Oct 24 -> Feb 25) with a 10/12 Salix Babylonica, in a similar / suitable area, to removed tree. IDK
