Dear Sirs,



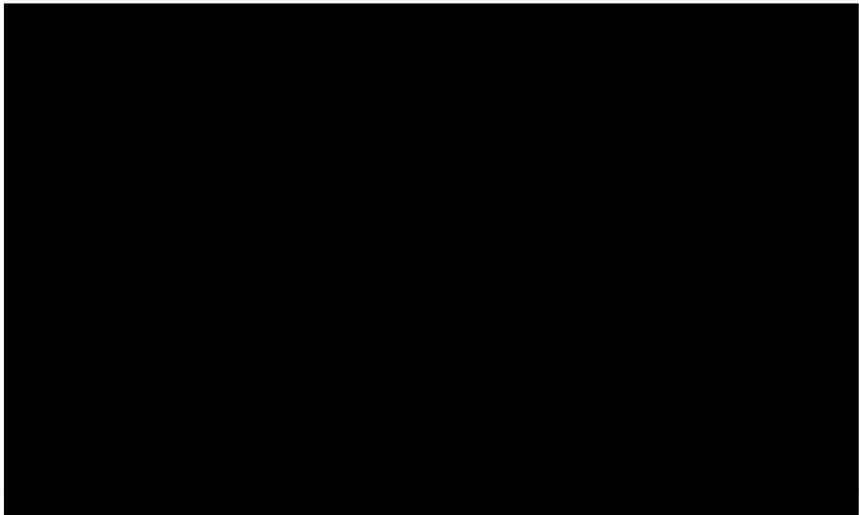
