- T.1 Mature london plane tree located in the car park.
- Crown lift up to approx 4.5m above ground level, by the removal of 2 branches back to source (see picture attached) and secondary branches.
- T.2 Mature beech tree adjacent to entrance gate,
- Crown lift up to approx 4.5m above ground level by the removal of secondary branches,
- T.3 Lime tree located in the corner of the carpark,
- Remove the dead top down to live wood (approx 2-2.5m) and reduce the live stem to match,

Reasons for proposed work;

- T.1-T.2 Provide clearance over car park and road.
- T.3 Remove dead section and reduce remaining stem to match.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
