A before and after school club is run from the mobile at Lantern Primary School providing essential childcare for the community. In addition, the mobile is used for a holiday club outside of school term time providing further childcare, and for the teaching of small groups in the school day. The Local Authority has a duty to provide sufficient quality early education and childcare places to enable parents to work or to undertake education or training which can lead to employment (Childcare Act, 2006). In the 2023 Spring Budget, central government announced that all primary schools will be expected toboffer wrapround care by September 2026. Therefore, the mobile is still required for the provision of childcare in line with the Council's statutory duties.
